Staff time will be recharged at cost plus 20% in addition to any associated vessel costs and exceptional administration requirements.

USE OF THE KLCB ANCHORAGE

Vessels arriving and departing the port of King's Lynn may use the anchorage area for layby free of charge. The following charges will apply for All other vessels:-
Up to 48 hours layby within the KLCB anchorage - No Charge.
After 48 hours layby within the KLCB anchorage - £85 per 24-hour period or part thereof.
After 48 hours layby within the KLCB anchorage - KLCB Levy dues applicable at £57.07 - one off payment.
